INTRODUCTION

Halal Assurance System (HAS) is a system set up by a halal certified company to assure the sustainability of halal production. The system is written and documented as *Halal Manual* and technically detailed in Standard Operating Procedure (SOP). This system was introduced firstly by LPPOMMUI and it is a compulsory requirement (prerequisite) in halal certification process. As the importance of HAS to be set up and implemented in a company holding halal certificate or company that intend to be halal certified, LPPOMMUI would like to invite halal certified companies to attend International Training on Halal Assurance System. The theme of the training is *The Importance of Halal Assurance System : Trend of Halal Products in Global Market*.

Participants from companies especially personnel who perform activities that affect product quality (halalness of the products) namely internal halal auditor, distributor/supplier companies and also auditors of halal certifier bodies are very welcomed to join this training.

The training will provide the guidance of how to set up HAS, raw materials knowledge and identification of haram critical control points and the assessment of HAS implementation.

This meeting will also give a forum for the exchange of information, ideas, experience amongst internal halal auditors from various companies all over the world especially on setting up and implementing of HAS. There will be also some discussion with the representative of Indonesian Government i.e Foods and Drugs Authority of Indonesia, Head of Quarantine and Minister of Industrial Affairs, with the topic of the importance of halal certification and quarantine policy in Indonesia and trend of halal products in global market.

The training will be held on 1st and 2nd July, 2008 at Gran Melia Hotel Jl Rasuna Said Jakarta, Indonesia.

At the same place, there will be also a workshop on Animal Derivatives Issues and Integration of HAS with ISO and HACCP on July 3, 2008 as part of the 2nd International Halal Exhibition which will be held at Kartika Expo Center- Balai Kartini, Jakarta (July, 3-6th, 2008 ; organized separately from the training).
